THIRD ORDER OF BUSINESS

Consideration of Resolution 2023-05, Approving a Proposed Budget for Fiscal Year 2023/2024 and Setting a Public Hearing Thereon Pursuant to Florida Law; Addressing Transmittal, Posting and Publication Requirements; Addressing Severability; and Providing an Effective Date

Ms. Suit presented Resolution 2023-05. She reviewed the proposed Fiscal Year 2024 budget, highlighting any line item increases, decreases and adjustments, compared to the Fiscal Year 2023 budget, and explained the reasons for any changes.

Consideration of Meadowbrook Acres of South-Central Florida, Landscape Maintenance Agreement

Ms. Suit presented the Meadowbrook Acres of South-Central Florida (Meadowbrook), Landscape Maintenance Agreement. Meadowbrook was sold to Continuum and Continuum billed the CDD despite the CDD not having an agreement with them. Meadowbrook is taking back maintenance and submitted a new proposal with an increased amount. Mr. Watts stated that language was added to recognize that the CDD made payments to Continuum without a formal assignment and that Meadowbrook taking the contract back and includes the updated contract amounts. Ms. Suit stated the amount increased because additional areas are included.

On MOTION by Mr. McConn and seconded by Mr. Crawford, with all in favor, the Meadowbrook Acres of South-Central Florida, Landscape Maintenance Agreement and authorizing the Chair to execute, was approved.
